
Quick Facts about Young Voters in Boston-Cambridge-Quincy, MA-NH¹: The Midterm Election Year 2006

The 2006 midterm election was the second major election in a row that saw an increase in the electoral participation of young people ages 18-29. Between 2002 and 2006, the percentage of eligible young people who voted increased by 3 percentage points to 25 percent, the single largest increase among all age groups nationally.³

In Boston-Cambridge-Quincy, MA-NH, the voter turnout rate among young people was 33 percent, one percentage point below Massachusetts' state average, but eight points above the national average. An estimated 189,000 young people from Boston-Cambridge-Quincy, MA-NH, voted in the 2006 elections.

There was a 29 percentage point gap between young people and adults in the U.S., and this gap was slightly smaller (28 percentage points) at the more local level of Boston-Cambridge-Quincy, MA-NH.

Voter Turnout Among Subgroups in Boston-Cambridge-Quincy, MA-NH

Women, high school graduates, and single people were the only subgroups of young people to vote at lower rates than the metropolitan average. Young men voted at a higher rate than did young women (2 percentage points). All subgroups of young people voted at lower rates than did their adult counterparts. See Table 1.
